Matters Arising:

- a) There had been no update from North Yorkshire Council regarding the crossing provision on the A162 and no date given for the Road Safety Committee meeting. The Clerk will write to the M.P. Keir Mather to ask for support. This to be backed up by photographs showing the number of cars parking in the village and those using the Ash Tree car park. Catherine Daniels is to source larger planters from a garden centre to be placed on the grass verge on the north side of the A162 to deter cars from parking there.
- b) Litter bins – have been replaced on Back Lane and Common Road and a new one installed at the bus shelter.
- c) A quotation has been received for the installation of the proposed village gateway signs on the A162. The Clerk is to apply to N Y Council for permission to install street furniture.
